Counsel for the Defendant filed a Motion to Continue Final Management Conference and Trial bearing only cause number CR-2010-00821. Upon informal inquiry the Court was advised that he intended to include cause number CR-2010-00836 on the motion and that he was in fact requesting a continuance in both cases. The motion indicated that the State had no opposition to the motion and that he was requesting a 30 day continuance. However, at a hearing on March 28, 2011, involving the case of the co-Defendant in CR-2010-00821, the parties agreed to continue the Trial date to a firm date of June 14, 2011. It was not clear whether this date had also been discussed with counsel for the Defendant in this case, but these Defendants remain joined for Trial and it would seem obvious that their cases need to be set at the same time. It appears that the parties' intent was to try CR-2010-00821 before trying CR-2010-00836. If any of the assumptions contained in the above Order are incorrect or are contrary to the desires of either counsel, they should notify the Court immediately.
