**STATUS MEMORANDUM**

15 COMES NOW, the State of Arizona, by the Mohave County Attorney and through  
16 the undersigned Chief Deputy County Attorney, JAMES J. ZACK, and Defense Counsel,  
17 STEPHEN R. GLAZER, hereby inform the Court, in response to its' minute order of April  
18 23, 2013, of the status of this case.

19 On April 26, 2013, the State spoke with the prosecutor in the U.S. Attorney's  
20 Office, Greg Fouratt, who is handling the prosecution of John Charles McCluskey. He  
21 informs the State that this Defendant pleaded guilty to federal charges in January, 2012,  
22 with the stipulation she will not be sentenced until after the McCluskey trial. That trial is  
23 scheduled to begin in July, 2013, and last four months.

24 The State would suggest the Court direct the Clerk to bring this file to the Court's  
25 attention again in January, 2014.


