Discussion ensues regarding release conditions.

IT IS FURTHER ORDERED setting a Case Management Conference on Tuesday, October 28, 2014 at 1:30 p.m.

IT IS FURTHER ORDERED affirming the Media Hearing on Tuesday, September 30, 2014 at 9:00 a.m.

The Court recesses at 1:55 p.m.
