**MOTION TO RELEASE
PREEMPTORY STRIKE LIST**

15 COMES NOW, the State of Arizona, by the Mohave County Attorney and through
16 the undersigned deputy, requests the Court release information regarding the preemptory
17 strikes exercised at the jury trial held on June 14, 2011. The State will be giving this
18 information to the Attorney General's Office for appellate purposes: State of Arizona v.
19 John Charles McCluskey, Court of Appeals Division One, 1-CA-CR 11-0464.

20 One of the issues presented in the Appellant's Brief involves the preemptory
21 strikes exercised in jury selection. The State is not requesting personal information about
22 the jurors, simply which jurors were stricken by the Defendant. The names of the stricken
23 jurors are provided in the Appellant's Brief. However, per information given to
24 undersigned deputy, these names were not in the record previously provided to the
25 Attorney General, making it difficult to check for accuracy in the briefs. The preemptory
strike information would only be used for appellate purposes.
