ARREST WARRANT

TO ALL PEACE OFFICERS OF THE STATE OF ARIZONA:

An Indictment or Information has been filed in this court against JOHN CHARLES MCCLUSKEY, charging that in Mohave County Arizona:

- COUNT 6: AGGRAVATED ASSAULT, CLASS 3 FELONY
- COUNT 7: AGGRAVATED ASSAULT, CLASS 3 FELONY
- COUNT 8: MISCONDUCT INVOLVING WEAPONS, CLASS 4 FELONY
